The bid document shall be collected during office hours (Monday to Friday 8:00-12:00a.m., 1:00-4:15p.m.; and Saturday 8:00-11:45a.m.) by presenting the payment advice. Presenting copy of renewed Trade License, Tax Clearance Certificate and VAT Registration Certificate is a must.
3. Bidders shall be quite sure to state direct line phone number, cell phone number, fax number and e-mail address of their organization correctly while collecting bid documents. Failure in receipt of bid communication due to incorrectness of the above will not be the responsibility of the bank.

Bid proposal shall be accompanied by the bid bond/Earnest Money Deposit in the amount of **Birr 60,000.00 (Sixty Thousand Birr)** for bid no **89/2018/19** and **Birr 36,000.00 (Thirty Six Thousand Birr)**, **Birr 34,000.00 (Thirty four Thousand Birr)** for bid no **90/2018/19** and **Birr 112,000.00 (One Hundred Twelve Thousand Birr)** for Bid no. **91/2018/19** in the form of Unconditional Bank Guarantee or Cash Payment Order (C.P.O.). **Bid bond/EMD in any other form is not acceptable.**

6. All bids must be deposited in the tender box prepared for this purpose at Commercial Bank of Ethiopia, Procurement Sub-Process, during office hours before **March 12, 2019 at 2:00 p.m. for Bid No. 89, 90 and 91/2018/19** at the place mentioned under no. 2 above.
7. Bid opening shall be held in the presence of bidders and/or their legal agents who wish to attend, on **March 12, 2019 at 2:30 p.m. for bid no. 89, 90 and 91/2018/19** at the place mentioned under no. 2 above.
8. Failure to comply any of the conditions from 2 - 5 above shall result in automatic rejection.
